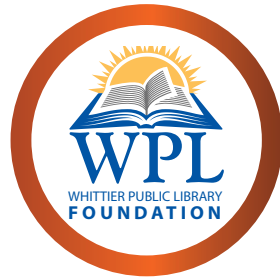

Food and drinks will be “to go” and the programs will be presented online.

**Auntie’s Bakery** will prepare the food and three local brewers — **Whittier Brewing Company**, **Angry Horse Brewing**, and **brewjeria company** will supply craft beers in 12 oz. cans.

Your “picnic” will be ready for you to pick up curbside at the Whittwood Branch Library between 5:00 and 7:00PM

on October 8. Be prepared to present your ID (You must be 21 or older). Then take your “picnic” home to enjoy.

The virtual program starts at 7:30PM and will include short interviews with our chefs and brewers and the latest information on the Central Library renovation.

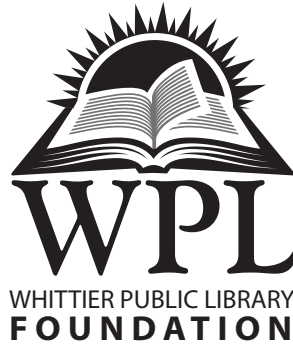
